- Simple management by IT

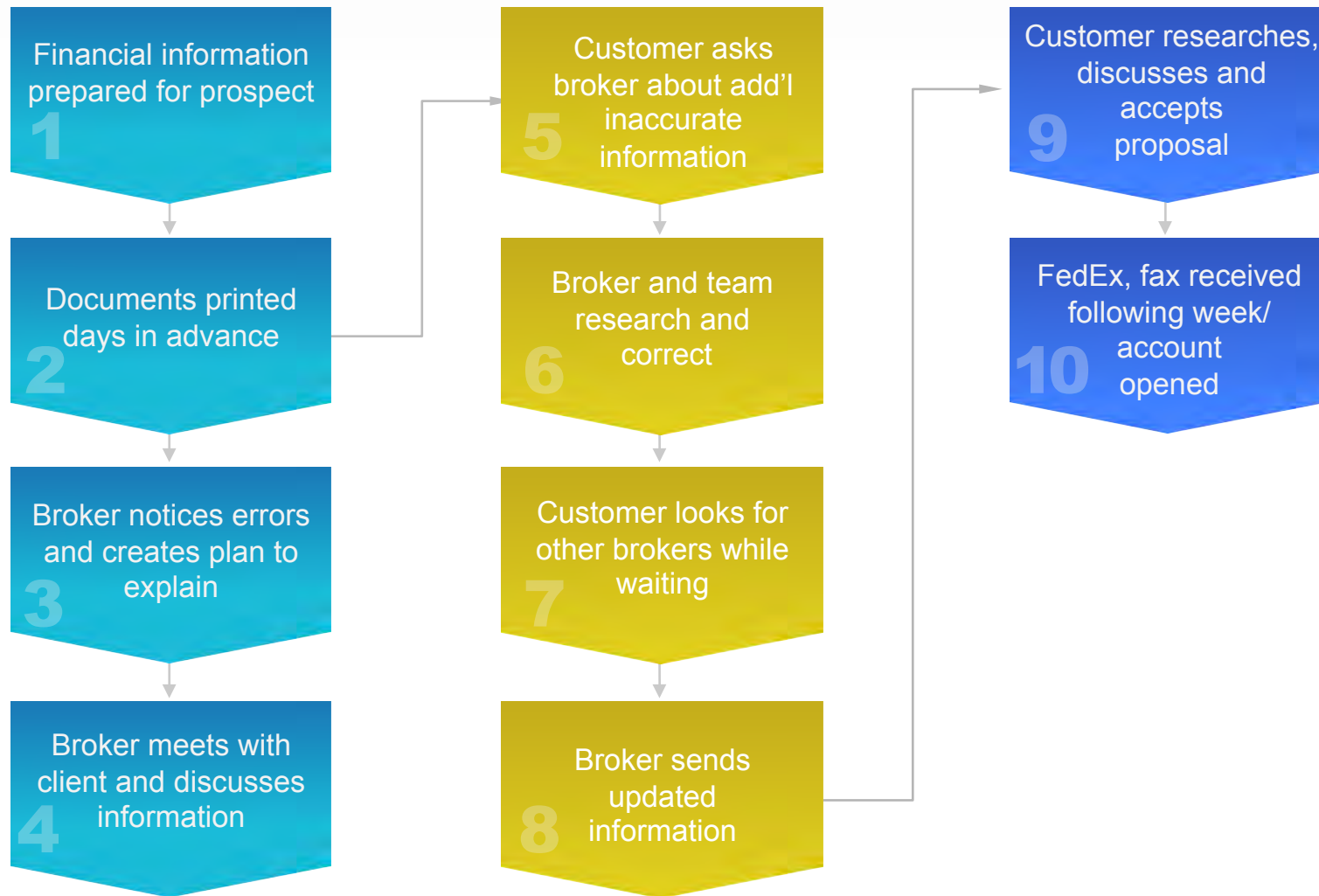

Wealth Management

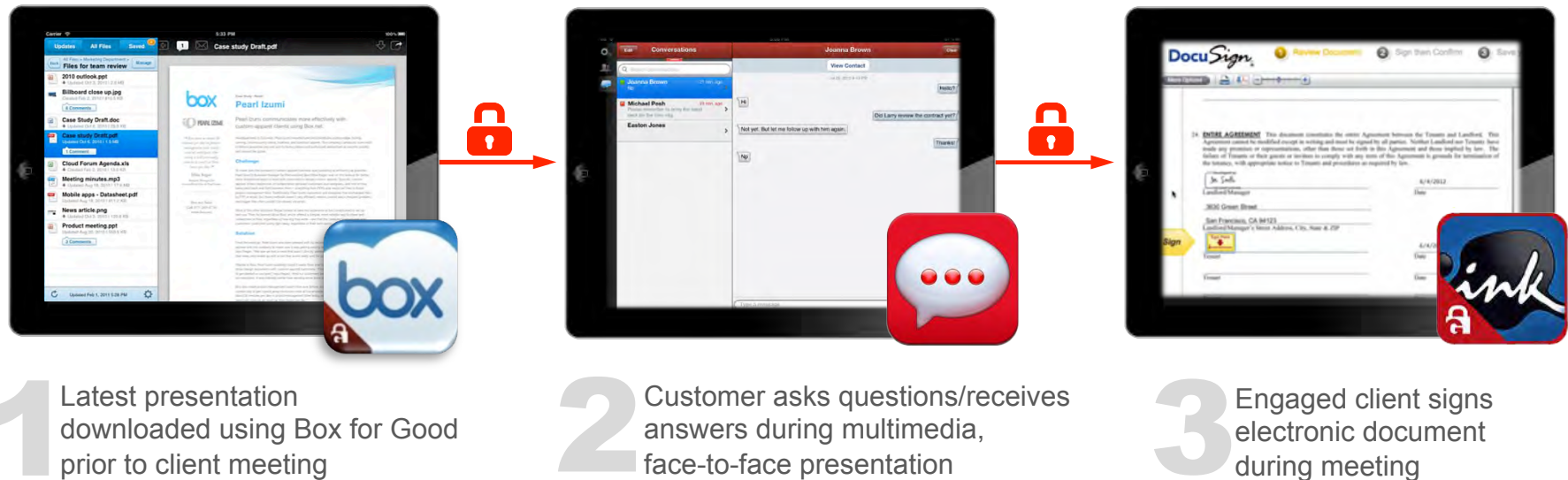
Process redesign initiative targeted to simplify the client acquisition process while reducing errors and lowering costs

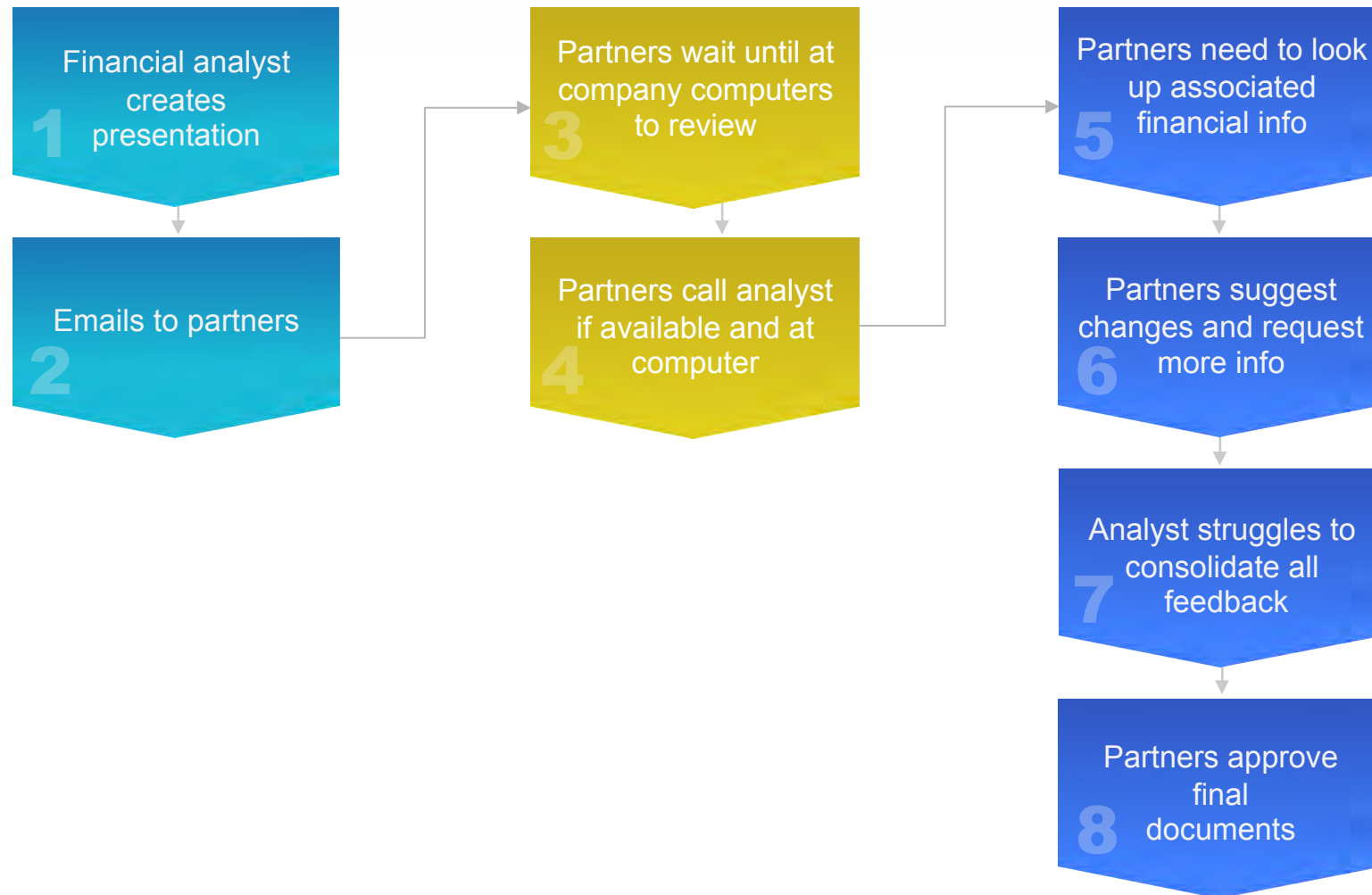


Example #2

Private Equity

Process redesign initiative targeted to streamline the document review processes and increase capacity for customer proposals

Old Process: Slow and Unnecessarily Repetitive



Excessive iterations and complicated integration of comments

New Process with Good: Simple and Secure



1 Financial analyst creates presentation and sends for review

2 Partners review presentation, related financial information and give feedback within the presentation from anywhere. Feedback automatically integrated for analyst

3 Analyst able to resolve questions checking presence and chatting with partners; presentation finalized with fewer reviews

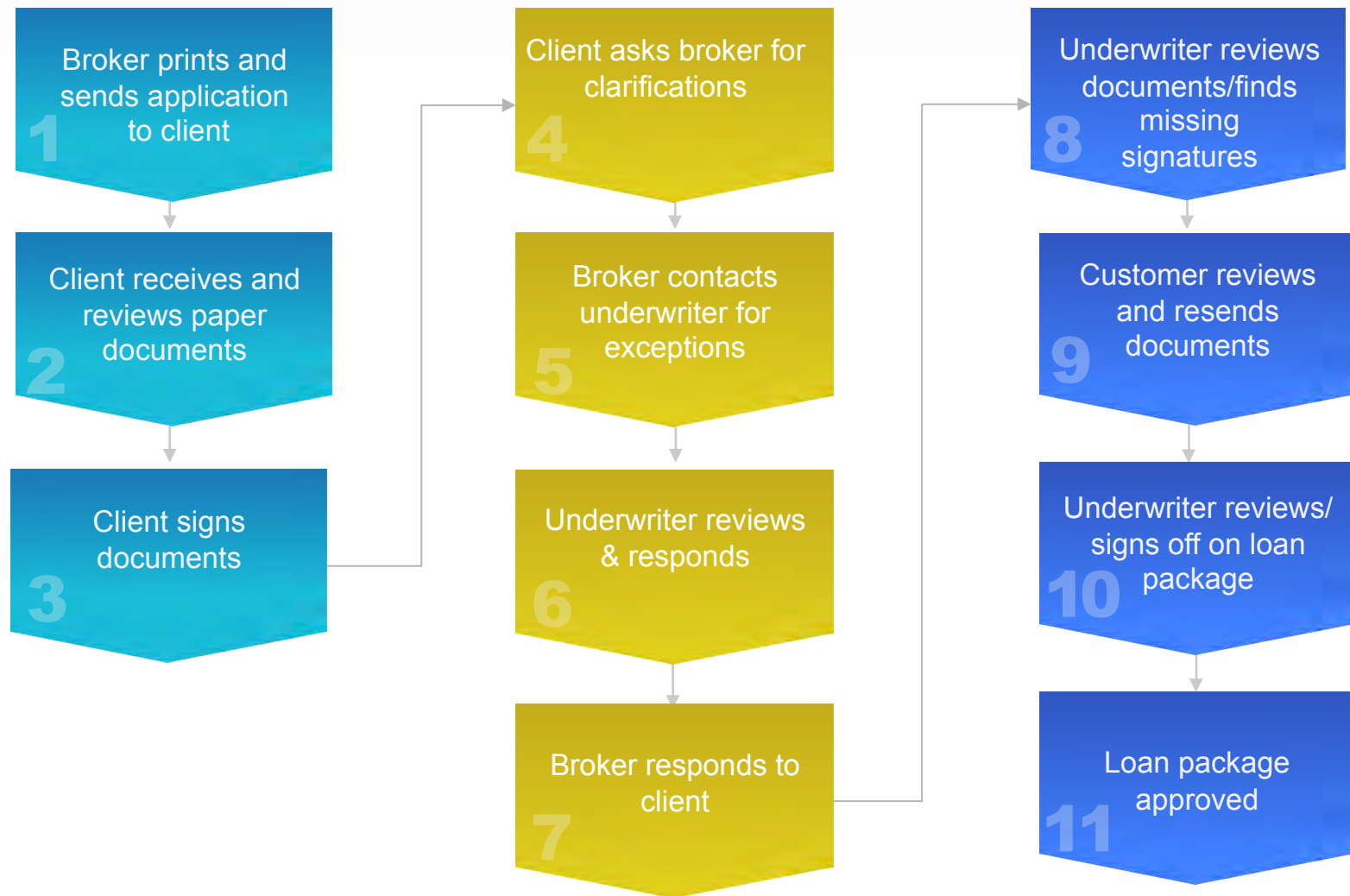


Example #3

Old Process: Paper Based and Slow



Logistically challenging, slow approval cycle and low customer satisfaction

New Process with Good: Simple and Secure



1 Broker resolves customer discrepancies with underwriter in real time via secure Instant Messaging

2 Customer reviews/digitally signs package with broker

3 Forms and statements submitted over email and filed automatically from loan number in subject line

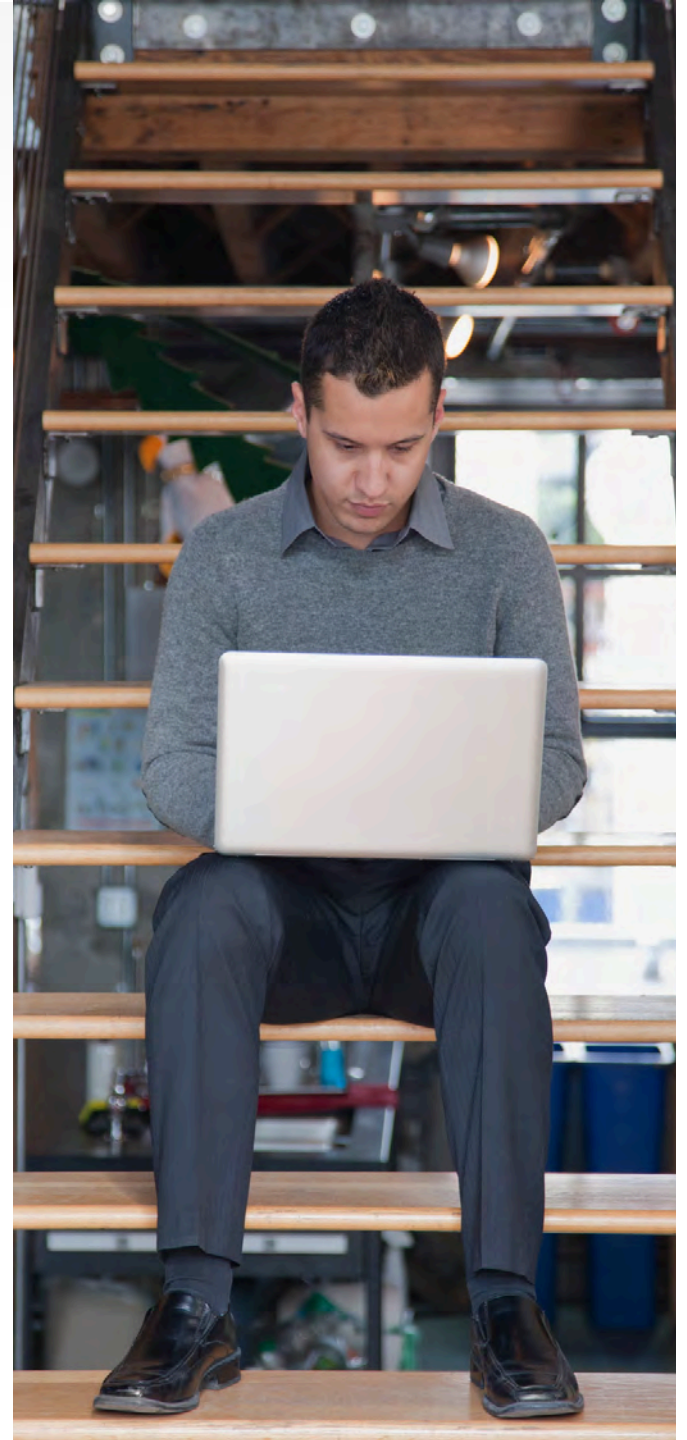
